Alternatives for Self Healing shall determine in good faith the extent to which it can reasonably control a cause, contingency, or circumstance that affects the performance of its obligations.

- 18. No Third Party Rights. Unless expressly granted in these Terms of Use or in the Privacy Policy, nothing herein or in the Privacy Policy is intended to confer any rights or remedies under these Terms of Use or the Privacy Policy on any persons other than you, Alternatives for Self Healing and its Affiliates. Nothing in these Terms of Use and the Privacy Policy is intended to relieve or discharge the obligation or liability of any third persons to you, Alternatives for Self Healing or its Affiliates, nor shall any provision give any third persons any right of subrogation or action over or against you, Alternatives for Self Healing or its Affiliates.
- 19. Assignment. You may not assign, transfer or delegate these Terms of Use or the Privacy Policy or any part of them without Alternatives for Self Healing's prior written consent. Alternatives for Self Healing may freely transfer, assign or delegate all or any part of these Terms of Use and the Privacy Policy, and any rights and duties hereunder or thereunder. These Terms of Use and Privacy Policy will be binding upon and inure to the benefit of the heirs, successors and permitted assignees of the parties.
- 20. Governing Law, Jurisdiction, and Venue. These Terms of Use and the Privacy Policy shall be governed by and construed in accordance with the laws of the State of California, without giving effect to any choice of law rules or principles. Any civil action or legal proceeding arising out of or relating to these Terms of Use or Privacy Policy shall be brought in the applicable Federal or State court located in [State]. Each party consents to the jurisdiction of such court in any such civil action or legal proceeding and waives any objection to the laying of venue of any such civil action or legal proceeding in such court. Any cause of action or claim you may have with respect to Alternatives for Self Healing must be commenced within one (1) year after it arises, except to the extent such limitation is not enforceable. To the fullest extent permitted by law, each party to this Terms of Use waives its or his or her right to a jury trial with respect to any dispute or other controversy arising from hereunder or your use of or access to the Alternatives for Self Healing services or website.
- 21. **Enforcement Costs**. If any civil action or other legal proceeding is brought for the enforcement of any of these Terms of Use or the Privacy Policy or because of an alleged dispute, breach, default or misrepresentation in connection with any provision of any of these Terms of Use or the Privacy Policy, the successful or prevailing party or parties shall be entitled to recover reasonable attorneys' fees, sales and use taxes, court costs and all expenses even if not taxable as court

- costs (including, without limitation, all such fees, taxes, costs and expenses incident to arbitration, appellate, bankruptcy and post-judgment proceedings), incurred in that proceeding, in addition to any other relief to which such party or parties may be entitled. Attorneys' fees shall include, without limitation, paralegal fees, investigative fees, administrative costs, sales and use taxes and all other charges billed by the attorney to the prevailing party (including fees and costs associated with collecting such amounts).
- 22. Waiver of Jury Trial. THE PARTIES HERETO HEREBY WAIVE TRIAL BY JURY IN ANY LITIGATION, SUIT OR PROCEEDING, IN ANY COURT WITH RESPECT TO, IN CONJUNCTION WITH, OR ARISING OUT OF THESE TERMS OF USE OR THE PRIVACY POLICY OR THE VALIDITY, PROTECTION, INTERPRETATION, COLLECTION OR ENFORCEMENT THEREOF, AND/OR PERFORMANCE OF ANY OF THE OBLIGATIONS OR SERVICES HEREUNDER OR THEREUNDER; PROVIDED, HOWEVER, THAT WITH RESPECT TO ANY COMPULSORY COUNTERCLAIM (I.E., A CLAIM BY A PARTY HERETO AGAINST ANOTHER PARTY WHICH, IF NOT BROUGHT IN SUCH ACTION, WOULD RESULT IN THE FIRST PARTY BEING FOREVER BARRED FROM BRINGING SUCH CLAIM), A PARTY HERETO SHALL HAVE THE RIGHT TO RAISE SUCH COMPULSORY COUNTERCLAIM IN ANY SUCH LITIGATION, SUIT OR PROCEEDING, WHETHER OR NOT IT IS BEING TRIED BY A JURY.
- 23. **Arbitration**. Except for violations of Section 6 of this Agreement (Intellectual Property), which may be brought in the state or federal courts in California, (applying California law, without reference to choice or conflict of laws principles), Client understands and acknowledges that any dispute regarding the The Gut Revolution program or Alternatives for Self Healing's performance of its obligations under this Agreement will be determined by submission to arbitration by the American Arbitration Association in Los Angeles, California, following the rules of the American Arbitration Association and applying California law (without reference to choice or conflict of laws principles), and not by a lawsuit or resort to court process, except as California law provides for judicial review or arbitration proceedings. The parties to this Agreement, by entering into it, are giving up their constitutional rights to have any such dispute decided by a court of law before a jury, and instead are accepting the use of arbitration.

It is the intention of the parties that this Agreement bind all parties whose claims may arise out of or are related to the The Gut Revolution program or services provided by Alternatives for Self Healing including any spouse or heirs of the Client and any children, whether born or unborn, at the time of the occurrence giving rise to any claim.

All claims based upon the same incident, transaction or related circumstances shall be arbitrated in one proceeding. A claim shall be waived and forever barred if (1) on the date notice thereof is received, the claim, if asserted in a civil action, would be barred by the applicable California statute of limitations, or (2) the claimant fails to pursue the arbitration claim in accordance with the procedures prescribed herein with reasonable diligence.

The prevailing party shall be entitled to recover the costs of arbitration unless otherwise determined by the arbitrator and shall be entitled to reasonable attorneys' fees as determined by the arbitrator.

- 24. **Waiver**. Failure to exercise or delay in exercising any right hereunder, or failure to insist upon or enforce strict performance of any provision of this Terms of Use, shall not be considered waiver thereof, which can only be made by signed writing. No single waiver shall be considered a continuing or permanent waiver.
- 25. Change of Law. If there is a change of any law, regulation or rule, federal, state or local, which affects the Agreement including these Terms of Use, which are incorporated by reference in the Agreement, or the activities of either party under the Agreement, or any change in the judicial or administrative interpretation of any such law, regulation or rule, and either party reasonably believes in good faith that the change will have a substantial adverse effect on that party's rights, obligations or operations associated with the Agreement, then that party may, upon written notice, require the other party to enter into good faith negotiations to renegotiate the terms of the Agreement including these Terms of Use. If the parties are unable to reach an agreement concerning the modification of the Agreement within forty-five (45) days after of date of the effective date of change, then either party may immediately terminate the Agreement by written notice to the other party.
- 26. Amendment. No amendment of this Agreement shall be binding on a party unless it is made in writing and signed by all the parties. Notwithstanding the foregoing, Alternatives for Self Healing may unilaterally amend this Agreement to the extent required by federal, state, or local law or regulation ("Applicable Law"). Any such changes are incorporated by reference into this Agreement without the need for signature by the parties and are effective as of the date established by Alternatives for Self Healing.
- 27. **Severability**. The provisions of this Terms of Use are severable, and in the event any provision hereof is determined to be invalid or unenforceable, such invalidity or un-enforceability shall not affect the validity or enforceability of the remaining

- provisions, but such provision shall be reformed, if reasonably possible, only to the extent necessary to make it enforceable.
- 28. **Miscellaneous**. These Terms of Use shall be construed without regard to any presumptions or rules requiring construction against the party causing the instrument to be drafted. Captions in this Terms of Use are used for convenience only and shall not limit, broaden, or qualify the text.
- 29. **Entire Agreement**. These Terms of Use, together with any Alternatives for Self Healing rules or policies referred to herein, represents the entire agreement between you and Alternatives for Self Healing concerning the subject matter hereof, and supersede all prior understandings, whether written or oral, concerning such subject matter. Alternatives for Self Healing may modify this Terms and Conditions of Use as set forth above.
